INDEMNIFICATION AND HOLD HARMLESS: I also agree to INDEMNIFY AND HOLD HARMLESS Professional Bronc Riders Association from any and all claims, actions, suits, procedures, costs, expenses, damages, and liabilities, including attorney's fees bought as a result of my involvement of Professional Bronc Riders Association events and to reimburse them for any such expenses incurred.

SEVERABILITY: The undersigned further expressly agrees that the foregoing waiver and assumption of risks agreement is intended to be as broad and inclusive as is permitted by the law of the State of New Mexico and Arizona, and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect.

ACKNOWLEDGEMENT OF UNDERSTANDING: I have read this waiver of liability, assumption of risk, and indemnity agreement, and fully understand its terms, and understand that I am giving up substantial rights, including my right to sue.
